SPECIFICATIONS: ABERDEEN BULK WATER SUPPLY PHASE 2: ENVIRONMENTAL CONSULTANTS

The Dr. Beyers Naude Municipality is currently implementing a project for the upgrading of the water infrastructure in Aberdeen (Eastern Cape). The work for the project entails the construction of new pipelines from two existing boreholes and one new borehole. The work also comprises the upgrading and new mechanical and electrical infrastructure at the 3 boreholes. The existing boreholes have existing pipe infrastructure that is not sufficient. The new borehole does not have any existing infrastructure. The existing pipeline routes still need to be surveyed to determine their location. Please see attached layout drawing.

No design work has been completed thus far. Neil Lyners & Associates are the appointed Civil Engineering Consultants on the project. We please require you to submit quotations taking into account the following requirements:

- 1. EIA for three pipelines from boreholes to town reservoir;
- 2. WULA for all river crossings;
- 3. Heritage applications;
- 4. Botanical studies;
- 5. Fresh water studies
- 6. Archaeological study
- 7. Paleontological study

Your quotations **must include all associated disbursements** costs to complete the above-mentioned processes.

Quotations must be placed in the municipal tender box, Robert Sobukwe Building, in sealed envelopes clearly marked "BEY-SCM-141", not later than 12h00 on Friday, 9th February 2018 and will be opened in public immediately thereafter.
