1. Introduction

Dr. Beyers Naude Local Municipality invites qualified service providers to submit proposals for conducting a forensic investigation into suspected cash and fuel theft within the municipality. The objective is to establish facts, quantify any losses, and recommend measures to strengthen internal controls.

2. Background

The municipality has identified discrepancies in cash handling and fuel usage discrepancies, raising concerns about potential misappropriation of funds. This investigation must be conducted in compliance with applicable laws and professional standards. Some work already done internally, Please enquire with Mr. H. Hendricks in this regard.

3. Scope of Work

The appointed service provider will be required to:

- Review cash handling processes, including collection, recording, and deposit procedures.
- Analyse fuel usage for specific vehicle(s) within the Protection services department.
- Analyse financial records, receipts, bank reconciliations, and supporting documentation for anomalies.
- Assess internal controls related to cash management.
- Conduct interviews and obtain sworn statements from relevant personnel.
- Perform digital forensic analysis of system logs and transaction records.
- Secure and preserve physical and electronic evidence in line with legal standards.
- Provide a fraud risk assessment and recommendations for improvement.

Methodology:

- Document review and transaction tracing.
- Forensic accounting techniques.
- Review of fuel requisitions and receipts/invoices.
- Interviews and evidence gathering.
- Compliance checks against municipal financial policies and legislation.

- Interim Report: Key findings and urgent recommendations.
- Final Report: Comprehensive analysis, evidence summary, conclusions, and recommendations.
- Presentation to Council: Summary of findings and proposed actions.
