4. All suppliers must be registered on the CENTRAL SUPPLIER DATABASE. Log onto [www.csd.gov.za](http://www.csd.gov.za) for registration
5. A current original tax clearance certificate of SARS "or" Sars Verification pins to be supplied.
6. A current certified Municipal (rates & services) clearance certificate to be submitted.
7. ICASA certificate for radio equipment type approval (vehicle tracking devices).
8. A current certified BBBEE status level certificate must be submitted in order to claim preference points.
  - 8.1 If the Certificate is not attached to this tender document, no points shall be awarded for B-BBEE status.
  - 8.2 In the case of a Trust, Consortium or Joint Venture, they will qualify for points for their B-BBEE status level as a legal entity provided that the entity submits their B-BBEE status level certificate.
