- 3. The tender will be evaluated on 80/20 system Where 80 points for price and a maximum of 20 points for specific goals.
- 4. To claim for specific goals prospective bidders MUST submit proof/required the required documents.
- All suppliers must be registered on the CENTRAL SUPPLIER DATABASE. Log onto <u>www.csd.gov.za</u> for registration
- 6. A current original tax clearance certificate of SARS "or" Sars Verification pins to be supplied.
- 7. A current certified Municipal (rates & services) clearance certificate to be submitted.
- 8. A current certified BBBEE status level certificate must be submitted in order to claim preference points.
  - 8.1 If the Certificate is not attached to this tender document, no points shall be awarded for B-BBEE status.
  - 8.2 In the case of a Trust, Consortium or Joint Venture, they will qualify for points for their B-BBEE status level as a legal entity provided that the entity submits their B-BBEE status level certificate.
