6. Local Content will form part of this tender at 100% Local Content.
7. Products must be SABS Approved. SABS Certificates must be attached.
8. A current original tax clearance certificate of SARS "or" Sars Verification pins to be supplied.
9. A current certified Municipal (rates & services) clearance certificate to be submitted.
10. A current certified BBBEE status level certificate must be submitted in order to claim preference points.
