Attention is specifically drawn to the fact that in terms of Section 50(2) of the Act an objection must be in relation to a specific individual property and not against the valuation roll as such. The forms for the lodging of objection are obtainable from Finance Offices of the Municipality in Graaff Reinet, Aberdeen, Nieu Bethesda, Jansenville, Klipplaat, Rietbron, Steytlerville and Willowmore, or Municipal website www.bnlm.gov.za.
