Notice is hereby given in terms of Section 49(1)(a)(i) of the Local Government Municipal Property Rates Act, 2004 (Act No. 6 of 2004), hereinafter referred to as the "Act", that the General Valuation Roll for the Financial Years 01 July 2024 to 30 June 2029 is open for public inspection at the Dr Beyers Naude Local Municipality offices 01 Feb -01 March 2024, **extended to 30 April 2024**, on Mondays to Fridays, during office hours 08:00 to 15:00. In Addition, the General Valuation Roll will be available at the DBNLM's website, [www.bnlim.gov.za](http://www.bnlim.gov.za).

An invitation is hereby made in terms of section 49(1)(a)(ii) of the Act that any owner of property or other person who so desires should lodge an objection with the Municipal Manager in respect of any matter reflected in, or omitted from, the General Valuation Roll within the above-mentioned period. Attention is specifically drawn to the fact that in terms of section 50(2) of the Act an objection must be in relation to a specific individual property and not against the General Valuation Roll as such.
