FOR REFURBISHMENT OF MECHANICAL AND ELECTRICAL WORKS AT GRAAFF-REINET WASTE WATER TREATMENT PLANT

Dr Beyers Naude Municipality (BNLM) hereby invites suitably qualified, registered, eligible and experienced mechanical engineering construction contractors to submit tenders for REFURBISHMENT OF MECHANICAL AND ELECTRICAL WORKS AT GRAAFF-REINET WASTE WATER TREATMENT PLANT.

The contract is based on the General Conditions of Contract for Construction Works, 3rd Edition, 2015 (GCC 2015)

It is **estimated** that tenderers should have a CIDB contractor grading designation of **3ME or higher**.

Tenders will be subjected to **strict eligibility and pre-qualification** criteria. Only tenderers who demonstrate suitable experience, have suitably qualified personnel and complies with the criteria stated in the **Tender Data**, are eligible to submit tenders.

Pre-qualification criteria based on **quality** (functionality), as well as **preferential procurement** will be applied.

Company Mechanical Engineering Construction Experience	40

For pre-qualification criteria based on quality (functionality), tenderers must achieve a **minimum threshold** score 60 % or 32 points in order to be evaluated further.

The **complete** eligibility and pre-qualification criteria are set out in the **Tender Data**.

The method for the evaluation of **responsive** tenders will be **Method 3: Financial Offer (80) and Preferences (20)**.

Preferences will be offered to tenderers for their Broad-Based Black Economic Empowerment (B-BBEE) status and level of contribution.

Tender documents will be ready and available for collection from **24 October 2022** at the Dr Beyers Naude Municipality Supply Chain Management Unit located on the corner of Oval Driver and Church Street in Graaff Reinet. Documents may be collected during working hours, **between 08:00 and 16:30 from Monday to Friday.**

A non-refundable tender deposit of **R 587.50** each (no cash acceptable) by EFT made out in favour of the Employer, is required on collection of the tender documents. The banking details are Standard Bank, Account Number 332104192, Branch Number 051001 Kindly include name of **business and tender number as a deposit reference.**

A compulsory clarification meeting will take place at the Robert Sobukwe Building in Graaff-Reinet, on Wednesday, 02 November 2022 starting at **11:00**. Thereafter, the tenderers will be taken on an inspection of the site. Attendance and completion of the attendance register(s) is compulsory for all Tenderers.

The closing time for receipt of tenders is **12:00 on Friday 11 November 2022 at Robert Sobukwe Building.**

Tenders may only be submitted on the tender documentation that is issued. Telegraphic, telephonic, telexed, facsimiled, e-mailed and late tenders will not be accepted. Requirements for sealing, addressing, delivery, opening and assessment of tenders are stated in the Tender Data.

No verbal and / or telephonic queries and clarifications will be entertained, instead these must be made in writing and will be responded to accordingly.
