It is *estimated* that tenderers should have a CIDB contractor grading designation of *3ME or higher*.

Tenders will be subjected to *strict eligibility and pre-qualification* criteria. Only tenderers who demonstrate suitable experience, have suitably qualified personnel and complies with the criteria stated in the **Tender Data**, are eligible to submit tenders.
