3. The tender will be evaluated on 80/20 system Where 80 points for price and a maximum of 20 points for specific goals
4. To claim for specific goals prospective bidders MUST submit proof/required the required documents.
5. All suppliers must be registered on the CENTRAL SUPPLIER DATABASE. Log onto www.csd.gov.za for registration
6. A current original tax clearance certificate of SARS "or" Sars Verification pins to be supplied.
7. A current certified Municipal (rates & services) clearance certificate to be submitted.
8. A current certified BBBEE status level certificate must be submitted in order to claim preference points.
 - 8.1 If the Certificate is not attached to this tender document, no points shall be awarded for B-BBEE status.
 - 8.2 In the case of a Trust, Consortium or Joint Venture, they will qualify for points for their B-BBEE status level as a legal entity provided that the entity submits their B-BBEE status level certificate.
9. Council is not bound to accept the lowest or any tender and reserves the right to accept any tender or part thereof.
10. Functionality will also form part of the tender evaluation, where tenderers need to score at least 60% (60 points) to qualify, based on the below functionality criteria:
