Safety Standards: Fencing must comply with local safety and quality regulations for outdoor sports facilities.

Gates: At least one access point (1.2m wide) should be integrated for players, officials, and maintenance.

Intermediate Posts: 50 mm x 2 mm hot-dipped galvanised round tubing.

Corner Posts: 76 mm x 2 mm HOT- galvanised round tubing including 2 x stays per corner post.

Foundations: Posts should be cast into concrete bases (at least 300mm)

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;

- 4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender.
