- 6. A current certified BBBEE status level certificate must be submitted in order to claim preference points.
  - 6.1 If the Certificate is not attached to this tender document, no points shall be awarded for B-BBEE status.
  - 6.2 In the case of a Trust, Consortium or Joint Venture, they will qualify for points for their B-BBEE status level as a legal entity provided that the entity submits their B-BBEE status level certificate.
