A compulsory clarification meeting with representatives of the Employer will be held at 10h00 on Tuesday, 25th July 2023 (close on time, if late, no attendance) at the Robert Sobukwe Building, Cnr of Church Street and Oval Drive, Graaff-Reinet. Documents will only be available at the site clarification meeting.
