5. A current original tax clearance certificate of SARS "or" Sars Verification pins to be supplied.
6. Proof of Registration with the Engineering Council of South Africa (ECSA) as Professional Engineer. This must be submitted for the Project Leader.
7. A current certified Municipal (rates & services) clearance certificate to be submitted.
8. Tenderers need to score a minimum of 70% for functionality
