6. Local Content will form part of this tender at 40% Local Content.
7. Products must be SABS Approved. SABS Certificates must be attached.
8. A current original tax clearance certificate of SARS "or" Sars Verification pins to be supplied.
9. A current certified Municipal (rates & services) clearance certificate to be submitted.
10. A current certified BBBEE status level certificate must be submitted in order to claim preference points.
  - 10.1 If the Certificate is not attached to this tender document, no points shall be awarded for B-BBEE status.
  - 10.2 In the case of a Trust, Consortium or Joint Venture, they will qualify for points for their B-BBEE status level as a legal entity provided that the entity submits their B-BBEE status level certificate.
